The award is scheduled to vest as to 6,128 stock units on January 10, 2009 and as to the remaining 6,129 stock units on January 10, 2011.

(3) Options were granted under the Company's Amended and Restated 2005 Stock Incentive Plan in a transaction exempt under Rule 16(b)-3. The options vest in four equal installments on each January 10 of 2008 through 2011.
