On July 20, 2011, Ecolab Inc. began distributing the following letter to employees.

As you are learning today, Ecolab has announced its intent to merge with Nalco in a transaction that truly transforms our company, and vaults us giant steps forward on our Strategy 2015 goals. Once the merger is final, Ecolab will be an \$11 billion+ world leader in cleaning, sanitation and water management solutions that help keep food safe, prevent the spread of infection and preserve natural resources. We will have market-leading water management expertise, serving the Institutional, F&B, Industrial and Energy markets. Our nearly 39,000 associates will serve customers in more than 160 countries, working towards our broader purpose of creating a cleaner, safer, and healthier world.

We're bringing together two strong companies with complementary capabilities, cultures and business models. Fundamental to our past and future success is our exceptional field organization, which in many ways mirrors Nalco's. We are both companies with high-touch service models that depend on the field organization's deep knowledge of customer needs, problem-solving orientation and application know-how to deliver the value that wins business and keeps customers loyal over time.

This merger is primarily driven by growth, not by an effort to drive down costs. We don't foresee any reduction in our sales and service organizations and intend to continue to invest in our R&D and customer-facing commercial teams, which are critical to making this merger deliver the benefits, value and the opportunities we've identified. The vast majority of Nalco and Ecolab employees should benefit favorably as there will be exciting opportunities for business growth, financial performance and career growth in the new organization.

This transaction is expected to close in the fourth quarter of this year. You should continue to operate in a business as usual mode. No changes are anticipated in our current customer relationships.

We do not anticipate many questions from our existing customer base that require any outreach on your part beyond your normal course of business. However, attached is

additional information on Nalco and the post-close merged Ecolab that you should review in case there are customer questions, or for review in your next customer conversation.

Again, it's business as usual. No collaboration or conversation with Nalco employees is appropriate until after the merger closes and you are provided direction from management.

We are extremely excited about the great potential of our new organization. Merging with Nalco will add additional avenues for growth in our existing markets and further enhance our ability to make the world a cleaner, healthier and safer place.
