**Item 8.01. Other Events.**

On January 18, 2012, HCP, Inc., a Maryland corporation (the *Company*), entered into an underwriting agreement (the *Underwriting Agreement*) with the underwriters named therein (the *Underwriters*) relating to the sale by the Company of \$450 million aggregate principal amount of 3.75% senior unsecured notes due 2019 (the *Notes*). On January 23, 2012, the Company completed its underwritten public offering of the Notes (the *Offering*). The net proceeds of the Offering are approximately \$443.7 million, which will be used to repay borrowings under the Company's revolving credit facility and for general corporate purposes. Additional details related to this Offering may be found in the Prospectus Supplement dated January 18, 2012 (the *Prospectus Supplement*), which was filed with the Securities and Exchange Commission (the *Commission*) on January 20, 2012.

The Notes are governed by the terms of the Indenture dated September 1, 1993 (the *Base Indenture*), between the Company and The Bank of New York Mellon Trust Company, N.A., as successor trustee to The Bank of New York, as trustee (the *Trustee*), which was filed as Exhibit 4.2 to the Company's Registration Statement on Form S-3/A (Registration No. 333-86654) filed with the Commission on May 21, 2002, as supplemented by the Supplemental Indenture dated January 24, 2011, between the Company and the Trustee (the *Supplemental Indenture*), which was filed as Exhibit 4.1 to the Company's Current Report on Form 8-K filed with the Commission on January 24, 2011.

The Notes will mature on February 1, 2019 and the Company will pay interest on the Notes semi-annually on February 1 and August 1, beginning on August 1, 2012. The Notes are senior unsecured obligations and rank equally with all of the Company's existing and future senior unsecured indebtedness.

The Company may redeem all or part of the Notes at any time at its option at a redemption price equal to the greater of: (i) 100% of the principal amount of the Notes to be redeemed, or (ii) the *make-whole* amounts applicable to the Notes to be redeemed as set forth in the section titled *Description of the Notes - Optional Redemption* in the Prospectus Supplement. In addition, the Notes are redeemable at a redemption price equal to 100% of the principal amount to be redeemed 90 days or fewer before their maturity. For more information, see the section entitled *Description of the Notes - Optional Redemption* in the Prospectus Supplement.

The Notes have been registered under the Securities Act of 1933, as amended, pursuant to an effective Registration Statement on Form S-3ASR (333-161721), filed with the Commission on September 4, 2009. The description of the Base Indenture, the Supplemental Indenture and the Notes are summaries and are qualified in their entirety by the terms of the Base Indenture, the Supplemental Indenture and the form of the Notes. Copies of the Underwriting Agreement, the Base Indenture (as previously filed), Supplemental Indenture (as previously filed) and the form of the Notes are filed as exhibits hereto and incorporated herein by reference.
