So with that, let's jump in. Slide 3 highlights that I am squarely focused on agriculture with 3 very clear priorities. . . . And lastly, our teams are working with great urgency to develop detailed plans to capture the \$1.3 billion worth of cost synergies in the Agriculture business from our announced merger with Dow.

Now we have a lot of work to do, but I am very confident in our ability to meet the ambitious objectives that we've laid out based on the strength of our business and the recent successes despite the challenging market that we face today in Agriculture. And my own past experience as part of being part of successful businesses in DuPont is really helping.

Now on the integration front, DuPont's steady portfolio transformation over the past several years required us to hone our integration capabilities. My own work on the original acquisition of Pioneer plus the successful efforts that I led on the Danisco and Solae integrations are really contributing today in our integration of Ag. So with that as a context, I want to share with you why I am so confident and excited about our long-term growth.

So on Slide 23, I'll close today, where, I think, Tim Hassinger began his presentation earlier, with a few comments about our proposed merger with Dow. Now I can tell you, our teams are very excited about the upcoming merger and the intended separation with the opportunity to create the world's leading production agriculture business. By combining both companies' seed and traits programs, the Ag business will have a capability to become a more significant innovation competitor to the rest of the industry in trait development. This will benefit both regional seed companies and farmers. Our Crop Protection business is also enhanced by this combination. Bringing these highly complementary product portfolios together, we will enable we will be able to offer growers a much broader suite of product options to improve their profitability and productivity.

Both companies' agricultural businesses share a rich history and a commitment to sustainable agriculture, and our cultures are very similar. So as we begin to make plans for integration, the Dow and DuPont integration teams have a strong commitment to realize synergies and to create this exciting future together.
