(1) The amount listed in Table II represents 50% of the original RSUP16 award, which was the minimum amount guaranteed to be paid out upon vesting. The award vested on March 4, 2014 and because the performance targets were achieved, the award was paid out at a performance rate of 150%. The shares coded "A" represent the portion attributable to this performance adjustment. The shares coded "F" were withheld to cover income tax obligations associated with the payout.
