The performance shares will be converted on a one-for-one basis into shares of Applied Materials common stock upon vesting, which vesting is scheduled to occur as follows: 21,153 shares are scheduled to vest on December 19, 2017, 10,576 shares are scheduled to vest on December 19, 2018 and 10,577 shares are scheduled to vest on December 19, 2019 (all vesting is subject to continued employment through each applicable vest date).
- (1) Applied Materials common stock upon vesting, which vesting is scheduled to occur as follows: 21,153 shares are scheduled to vest on December 19, 2017, 10,576 shares are scheduled to vest on December 19, 2018 and 10,577 shares are scheduled to vest on December 19, 2019 (all vesting is subject to continued employment through each applicable vest date).
