- On November 10, 2009, as partial consideration for services being rendered as a director, Mariner Energy, Inc. issued 3,479 shares of common stock to Ms. Sugg as a restricted stock grant under its Stock Incentive Plan, as amended and restated from time to time. The (1) shares vest one-third on each of the next three regularly-scheduled annual meetings of the issuer's stockholders following the date of grant, assuming Ms. Sugg remains a director. The number of shares granted was determined by reference to the closing price per share of the issuer's common stock on the New York Stock Exchange on November 10, 2009 of \$14.37.
