- (3) Includes 1,756 shares acquired through Employee Stock Purchase Plan, 17,541 unvested Restricted Stock Units and 7,000 shares that are jointly owned by the Reporting Person and his spouse.
- (4) Options to purchase 125,000 shares were issued to the Reporting Person on May 18, 2006. The options vested in five equal annual installments (25,000 per year) on the first through fifth anniversaries of the grant date.
- (5) Options to purchase 40,000 shares were issued to the Reporting Person on May 5, 2006. The options vested in five equal annual installments (8,000 per year) on the first through fifth anniversaries of the grant date.
