(1) Vesting of restricted stock units ("RSUs") granted to the Reporting Person on February 24, 2014.

(2) The sale reported on this Form 4 was effected pursuant to a Rule 10b5-1 trading plan, and is an exempt transaction pursuant to Section 16b-3(e) - payment of exercise price or tax liability by delivering or withholding securities incident to the receipt, exercise or vesting of a security issued in accordance with Rule 16b-3. All of the shares reported as disposed of in this Form 4 were relinquished by the Reporting Person and cancelled by the Issuer in exchange for the Issuer's agreement to pay federal and state tax withholding obligations of the Reporting Person resulting from the vesting of RSUs. The Reporting Person did not sell or otherwise dispose of any of the shares reported on this Form 4 for any reason other than to cover required taxes.

(3) Represents the aggregate of sales effected on the same day at different prices.

(4) Represents the weighted average sales price per share. The shares sold at prices ranging from \$8.32 to \$8.3801 per share.
