 - (1) Consists of 35,000 shares of restricted common stock granted to Mr. Effren on May 12, 2008. Restrictions on Mr. Effren's shares lapse as to one-fourth (1/4) of such shares on each anniversary of the date of grant, commencing one year from the date of grant. Mr. Effren is entitled to vote such restricted shares, subject to forfeiture in accordance with the terms of the grant.
 - (2) Includes 6,918 shares of nonqualified stock options granted to Mr. Effren on January 17, 2008 which vest on the anniversary of the grant date and 350,000 shares of nonqualified stock options granted on September 21, 2007 which vest one-third (1/3) annually on each of the first three anniversaries of the grant date.
