- (2) Reflects additional phantom stock units received by the Reporting Person upon conversion of dividend equivalents from September 30, 2009 to the present.
- (3) All 11,060 shares being reported are subject to certain restrictions (including possible forfeiture) applicable to restricted stock grants under the 2000 Stock Incentive Plan, the 2009 Long-Term Incentive Plan, and the Restricted Stock Award Agreements.
