- (1) Conversion or exercise price of 1 for 1. The Phantom Units represent compensation deferred by the Reporting Person into interests held through the Vornado Realty Trust Nonqualified Deferred Compensation Plan that are valued with respect to the underlying security, which in this case is shares of Vornado Realty Trust 5.70% Series k Preferred Stock ("Preferred E"). The Reporting Person has no right to take possession of the underlying security.
- (2) The Phantom Units become payable in cash to the Reporting Person commencing upon a distribution at a future date from the Vornado Realty Trust Nonqualified Deferred Compensation Plan.
- (3) Represents weighted average purchase price. These preferred shares were purchased through the execution of a single market order at prices ranging between \$25.4481 and \$25.00. Full information regarding the number of shares purchased at each separate price will be provided by the reporting person upon request to the staff of the Securities and Exchange Commission, the issuer, or a security holder of the issuer.
