As a result of Voyager Learning Company's (the "Company") ongoing efforts related to its earnings restatement, which was filed on Form 10-K on August 31, 2007, Voyager Learning Company will not file its Quarterly Report on Form 10-Q for the period ending June 30, 2008 within the prescribed period. The Company believes that this delay cannot be eliminated without unreasonable effort or expense. As previously announced, the Company restated certain of its previously issued financial statements. As a result of the restatement process, the Company has not been able to complete its financial statements for fiscal years 2006 and 2007. The Company is continuing to work with KPMG LLP, the Company's independent registered public accounting firm for fiscal year 2006, to complete the audit for the 2006 fiscal year and intends to file the Form 10-K followed by Form 10-Q's for the fiscal year 2006 as soon as reasonably possible. The Company will continue to work with Whitley Penn LLP, the Company's independent registered public accounting firm for fiscal years 2007 and 2008, to file its Form 10-K followed by Form 10-Q's for fiscal year 2007 as well as its Form 10-Q's for fiscal 2008 as soon as reasonably possible.
