Unilever NV announces that on 26 September 2007 it purchased 474,837 Unilever NV ordinary shares (in the form of depositary receipts thereof) at prices between euro 21.810 and euro 22.040 per share. The purchased shares will be held as treasury shares.

Unilever NV also announces that 450 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 95,489,805 Unilever NV ordinary shares in treasury, and has 1,619,237,895 Unilever NV ordinary shares in issue (excluding treasury shares).
