Unilever NV also announces that 76,077 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, hold 115,997,416 Unilever NV ordinary shares in treasury and has 1,598,730,284 ordinary NV shares in circulation.
