<b>Issuer:</b>	Capital One Capital IV (the Trust), a Delaware statutory trust, the only assets of which will be Capital Efficient Notes, which are junior subordinated debt securities issued by Capital One Financial Corporation (Capital One), referred to as CENts. Capital One will own all common securities of the Trust.

accrued and unpaid distributions. The capital securities may be redeemed by Capital One at any time upon a Tax Event or a Rating Agency Event, in whole but not in part, at their liquidation amount or, in the case of a redemption before February 17, 2032, if greater, a make-whole price, in either case plus accrued and unpaid distributions. The capital securities may be redeemed by Capital One at any time, in whole but not in part, upon the occurrence of a Capital Treatment Event or an Investment Company Event, at 100% of their liquidation amount, plus accrued and unpaid distributions.

**Make-Whole prior to February 17, 2032:**

Discounted present value of Treasury plus 37.5 basis points unless a Tax Event or a Rating Agency Event has occurred.

**Make-Whole for Tax Event or Rating Agency Event:**

Discounted present value of Treasury plus 50 basis points.

<b>Deferral Provision:</b>	The Trust will defer payments on the 6.745% Capital Securities for up to 10 years if Capital One defers payments on the CENts. Payments cannot be deferred beyond the final repayment date of the CENts on February 5, 2082. Any deferred payments will accrue additional interest at the then applicable rate, compounded on each interest payment date.
<b>Replacement Capital Covenant:</b>	A replacement capital covenant will apply until February 5, 2062. The dates referred to in the prospectus supplement on which the applicable percentage and the types of securities that constitute qualifying capital securities (as therein defined) will change are February 5, 2032 and February 5, 2052.

<b>Underwriting Commissions:</b>	\$5,000,000
<b>Use of Proceeds:</b>	General corporate purposes, which may include repurchases of shares of Capital One common stock, as well as to redeem junior subordinated debt securities underlying currently outstanding trust preferred securities issued by certain of Capital One's subsidiary trusts.
