**Item 8.01 Other Events.**

Today, First Interstate BancSystem, Inc. (the Registrant ) announced its intention to redeem \$41,238,000 of its junior subordinated deferrable interest debentures maturing March 26, 2033 in the aggregate amount of \$41,238,000 ( Subordinated Debentures ). Under the terms of the issuance, the redemption of the Subordinated Debentures will cause a mandatory redemption of 40,000 floating rate mandatorily redeemable capital trust preferred securities and all common securities issued by First Interstate Statutory Trust I, an unconsolidated subsidiary of the Registrant. The redemption is expected to occur on June 26, 2012.
