This Amendment No. 1 (this Amendment) to the Schedule 13G (the Schedule 13G) relates to shares of Common Stock, par value \$0.001 per share (the Common Stock), of Cooper-Standard Holdings Inc., a Delaware corporation (the Issuer), and is being filed on behalf of (i) Archer Capital Management, L.P. (Archer), a Delaware limited partnership, as the investment manager to certain private investment funds (the Funds), (ii) Canton Holdings, L.L.C. (Canton), a Delaware limited liability company, as the general partner of Archer, (iii) Joshua A. Lobel, an individual, as a principal of Canton, and (iv) Eric J. Edidin, an individual, as a principal of Canton (the persons mentioned in (i), (ii), (iii) and (iv) above are referred to as the Reporting Persons). All shares of Common Stock reported in this Amendment are held by the Funds.

This Amendment amends and restates in the Schedule 13G as set forth below.

- (a) Canton, Archer, Mr. Lobel and Mr. Edidin may be deemed the beneficial owners of the 529,589 shares of Common Stock held by the Funds, which consists of (i) 347,058 shares of Common Stock and (ii) warrants exercisable to purchase 182,531 shares of Common Stock.
- (b) Canton, Archer, Mr. Lobel and Mr. Edidin may be deemed the beneficial owners of 3.1% of the Issuer's outstanding shares of Common Stock. This percentage was calculated by dividing (i) the number of shares of Common Stock reported in Item 4(a) held by the Reporting Persons by (ii) the sum of (A) the 17,124,273 shares of Common Stock outstanding as of October 28, 2014, as reported in the 10-Q filed by the Issuer with the Securities and Exchange Commission on October 31, 2014 and (B) 182,531, the number of warrants exercisable to purchase shares of Common Stock held by the Funds.
- (c) Canton, Archer, Mr. Lobel and Edidin have the shared power to vote and dispose of the 529,589 shares of Common Stock held by the Funds.
