 (1) The phantom stock units were awarded under the nonqualified deferred compensation plan in which directors could elect to defer their directors' fees by receiving phantom stock units payable in cash upon separation from service from the board. The plan was frozen on 12/31/2004. It is anticipated that a new nonqualified plan will be adopted during 2005 that will not include phantom shares in which the Company absorbed market price fluctuations. Until a new plan is adopted all directors' fees will be paid in cash.  
 (2) Upon separation from service from the Board, phantom stock units will be settled in cash at the then current market price of common stock.
