- (1) On March 14, 2005, Mr. Winn was issued 460 Deferred Stock Units ("DSU's") by NRG Energy, Inc. under NRG Energy, Inc.'s Long Term Incentive Plan (the "LTIP"). Each DSU is equivalent in value to one share of NRG's Common Stock, par value \$0.01. On December 5, 2007, all of the originally granted DSU's vested. Pursuant to the LTIP, Mr. Winn elected to satisfy his tax withholding obligation upon the exchange of common stock for DSU's by surrendering a number of shares of common stock having a value on the date of the exchange equal to the tax withholding obligation. This form is being filed to reflect the surrender of 200 shares of common stock to satisfy the grantee's tax withholding obligation.
