Each RSU represents a contingent right to receive one share of Winn-Dixie Stores, Inc. common stock.
 - (2) The amount of securities owned balance includes 11,004 RSUs for which stock certificates will be issued upon vesting.
 - (3) The Option shall vest in equal annual installments over 3 years beginning with the first anniversary of the date of grant.
