The restricted stock units vest over three years
- (1) (1/3 on February 08, 2012; 1/3 on January 2, 2013; and 1/3 on January 2, 2014). Of the 35,688 shares of common stock, 11,896 shares were issued on February 08, 2012, of which 5,136 shares were withheld to satisfy payment of the Issuer's tax withholding obligation. The remaining 23,792 shares are scheduled to be issued on the two remaining vesting dates and taxes for these future issuances will be withheld at the time the shares are issued.
