Pursuant to the terms of the Plan, 11,617 shares were forfeited by Mr. Scheiwe when he resigned from Footstar, Inc.'s Board of Directors effective immediately on May 5, 2009 following shareholder adoption and approval of a plan of complete dissolution and liquidation of Footstar, Inc.
