- (1) On September 10, 2011, 5,917 shares of United Natural Foods, Inc. (the "Company") restricted stock units vested. The Company retained 1,906 shares on September 10, 2011 to satisfy certain tax withholding obligations in connection with the vesting of such shares.
On September 11, 2011, 8,125 shares of United Natural Foods, Inc. (the "Company") restricted stock units vested. Of these shares, the reporting person had previously elected to defer 2,031 shares to the Company's Deferred Stock Plan. The Company retained 2,602 shares on September 11, 2011 to satisfy certain tax withholding obligations in connection with the vesting of such shares.
- (3) Includes 258 shares of common stock allocated to the reporting person under the United Natural Foods, Inc. Employee Stock Ownership Plan as well as 2,260 shares held by a daughter(1) of the reporting person, 1,500 shares held by a daughter(2) of the reporting person, and 1,500 shares held by the brother of the reporting person, as custodian for a daughter(3) of the reporting person as of September 12, 2011.
- (4) Each restricted stock unit represents the right to receive one share of United Natural Foods, Inc. common stock upon vesting in accordance with the terms of the reporting person's restricted stock unit agreement.
- (5) The restricted stock units vest in four equal annual installments beginning on the first anniversary of the date of grant.
- (6) The security converts to common stock on a one-for-one basis subject to the terms of the United Natural Foods, Inc. Deferred Compensation Plan.
