The total amount of securities reported as indirectly owned by the reporting person includes 2.7460 shares acquired from December 1,

- (1) 2008 through December 31, 2008, pursuant to the Company's 401(k) Plan (?Plan?). The information is based on a report dated December 31, 2008, provided by the Plan Trustee.
- (2) Restricted Stock Units ("RSUs") converted to phantom stock units and deferred under the Company's Deferred Compensation Plan. The units are payable only in shares of Common Stock at the end of the deferral period.
- (3) Each deferred phantom stock unit is equivalent to one share of Common Stock of The Hershey Company.
- (4) Restricted Stock Units (?RSUs?) granted on January 8, 2007 of which 250 RSUs vested on January 8, 2009. The remaining RSUs will vest according to the following schedule: 250 on January 8, 2010 and 250 on January 8, 2011. Once vested, RSUs may be: (1) settled in cash having a value equivalent to the closing price of Common Stock on the New York Stock Exchange on the day preceding the vesting

date, in an equal number of shares of Common Stock, or in a combination of cash and Common Stock; or (2) deferred under the Company's Deferred Compensation Plan. RSUs deferred as phantom stock units are payable only in shares of Common Stock at the end of the deferral period. The reporting person has elected to defer payment of the RSU award in phantom shares of Common Stock (except for shares withheld to satisfy tax withholding obligations).

- (5) Each Restricted Stock Unit represents a contingent right to receive one share of Common Stock of The Hershey Company or its cash equivalent.
