***“América Móvil acquires Digicel’s operations in Honduras and sells its operations in Jamaica”***

Mexico City, Mexico, November 30, 2011 -- América Móvil, S.A.B. de C.V. (“**AMX**”) (BMV: **AMX**; NYSE: **AMX**; NASDAQ: **AMOV**; LATIBEX: **XAMXL**), announced today that as a result of the agreement entered into with Digicel Group Limited and its affiliates (“**Digicel**”), during the first quarter of 2011, has acquired as of the date hereof 100% of Digicel’s operations in Honduras and consummated the sale of its operations in Jamaica to Digicel.
