- (1) Includes 2.906 shares of stock acquired through the reinvestment of dividends on September 30, 2005, at a price of \$62.0622 per share.  
The number of underlying securities is based on the stock fund balance on September 30, 2005. The actual number of shares issuable upon the distribution date is not determinable since the stock fund is a unitized account consisting of 96% company stock and 4% money market fund. The stock account balance reflected in this report is based on a September 30, 2005 stock fund price of \$62.05 per share.
- (2) The phantom stock units convert to the common stock's cash value on a one-for-one basis.
- (3) The phantom stock units were accrued under the Johnson Controls Equalization 401(k) Benefit Plan and are to be settled 100% in cash upon the reporting person's retirement or other termination of service.
- (4) Includes 0.584 phantom stock units acquired through the reinvestment of dividends on September 30, 2005, at a price of \$62.05 per phantom unit.
- (5) The phantom stock units were accrued under the Johnson Controls Executive Incentive Compensation Plan and are to be settled 100% in cash upon the reporting person's retirement or other termination of service.
- (6) Includes 25.364 phantom stock units acquired through the reinvestment of dividends on September 30, 2005, at a price of \$62.05 per phantom unit.
- (7) The restricted stock units were accrued under the Johnson Controls Restricted Stock Plan. The units represent the reinvestment of dividends and are to be settled 100% in cash upon the vesting of the reporting person's Restricted Stock Grant.
- (8) Includes 49.784 phantom stock units acquired through the reinvestment of dividends on September 30, 2005, at a price of \$62.05 per phantom unit.
- (9) Fifty percent of the options become exercisable two years after the grant date; the remaining 50%, three years after grant date.
