(4) Shares are held by Full Value Offshore Fund, Ltd. Full Value Offshore Fund, Ltd. is in the process of liquidating and winding up, and as a result has withdrawn as a member of the Section 13(d) filing group referenced in Explanation 2 above.

(5) Shares are held by Opportunity Income Plus Fund, LP.

(6) Shares are held by Bulldog Investors General Partnership. The general partners of Bulldog Investors General Partnership include Opportunity Partners, LP, Calapasas West Partners, LP, Full Value Special Situations Fund, LP, Full Value Partners, LP, Opportunity Income Plus, LP, MCM Opportunity Partners, LP, Steady Gain Partners, LP and Mercury Partners, LP, which together may constitute a group.
