**Item 1. Security and Issuer.**

The name of the issuer is Talon International, Inc., a Delaware corporation (the “Issuer”). The Issuer’s principal executive offices are located at 21900 Burbank Blvd., Suite 270, Woodland Hills, California 91367. The title of the class of equity securities to which this statement on Schedule 13D (this “Schedule 13D”) relates is the common stock of the Issuer, par value \$0.001 per share (the “Common Stock”)

**Item 2. Identity and Background.**

(a) This Schedule 13D is filed by Zipper Holdings, LLC (“Zipper”) and Mark Dyne (“Dyne”). Zipper and Dyne are sometimes referred to together as the “Reporting Persons.” Dyne is the 100% member and sole manager of Zipper, and exercises voting and dispositive power over the securities held by Zipper. Dyne is also the Chairman of the Board of Directors of the Issuer. The Reporting Persons do not admit they constitute a group.

(b) The business address of each of the Reporting Persons is Zipper Holdings, LLC, 15260 Ventura Blvd., 20<sup>th</sup> Floor, Sherman Oaks, CA 91403.

(c) The principal business of Zipper is making and holding investments in various business enterprises. Dyne’s principal occupation is as the Chief Executive Officer and Managing Partner of Europlay Capital Advisors, LLC, a merchant banking and advisory firm.

(d) During the last five years, none of the Reporting Persons have been convicted in a criminal proceeding (excluding traffic violations or similar misdemeanors).

(e) During the last five years, none of the Reporting Persons have been a party to a civil proceeding of a judicial or administrative body of competent jurisdiction and as a result of such proceeding was or is subject to a judgment, decree or final order enjoining future violations of, or prohibiting or mandating activities subject to, federal or state securities laws or finding any violation with respect to such laws.

(f) Zipper is organized as a limited liability company in Delaware. Dyne is a citizen of the Republic of South Africa.

**Item 3. Source and Amount of Funds or Other Consideration.**

On July 12, 2013, Zipper used \$750,000 to purchase from the Issuer 8,333,333 shares of Common Stock in a private placement pursuant to the terms of a Subscription Agreement dated July 12, 2013 between the Issuer and Zipper (the "Subscription Agreement"). The funds used to purchase these shares of Common Stock reported in this Schedule 13D were from contributions made by Dyne.

**Item 4. Purpose of Transaction.**

On July 12, 2013, the Issuer offered and sold to a number of unaffiliated investors, in a private placement transaction, an aggregate of 61,111,109 shares of Common Stock at a price of \$0.09 per share, resulting in total proceeds to the Issuer of \$5,500,000 (the "Private Placement"). The Reporting Persons acquired the Common Stock reported in this Schedule 13D as part of the Private Placement, pursuant to the Subscription Agreement. Such shares of Common Stock are held by the Reporting Persons for investment purposes.



The Issuer used the funds received from Zipper and other investors participating in the Private Placement as part of the cash purchase paid by the Issuer to repurchase and redeem all of its previously outstanding shares of Series B Convertible Preferred Stock on July 12, 2013 pursuant to the terms of a Securities Redemption Agreement between the Issuer and CVC California, LLC (such transaction, the "Redemption"). The closing of the Private Placement was expressly conditioned upon the contemporaneous closing of the Redemption transaction.

In connection with the Subscription Agreement, the Issuer also entered into a Registration Rights Agreement dated July 12, 2013 with Zipper and the other investors participating in the Private Placement (the "Registration Rights Agreement"). The Registration Rights Agreement provides for demand registration rights, such that upon the demand of holders of at least 25% of the shares of Common Stock issued in the Private Placement and subject to certain conditions, the Issuer is required to file a Form S-1 registration statement covering the shares issued in the Private Placement and requested to be included in such registration. The Registration Rights Agreement also provides certain piggyback rights, in which the holders of Common Stock acquired in the Private Placement have the right to include those shares in a Company-initiated registration.

Dyne is the Chairman of the Board of Directors of Issuer. Because of Dyne's personal interest in the Private Placement, Dyne recused himself from voting as a member of the Board on the Private Placement and the Redemption.

The Subscription Agreement is attached hereto as Exhibit 1, and incorporated herein by reference. The Registration Rights Agreement is attached hereto as Exhibit 2, and incorporated herein by reference.

Other than as set forth herein, the Reporting Persons have no present plans or proposals which relate to, or could result in, any of the matters referred to in paragraphs (a) through (j) of Item 4 of Schedule 13D. The Reporting Persons may, at any time and from time to time, renew or reconsider their position and formulate plans or proposals with respect to any of the matters referred to in paragraphs (a) through (j) of Item 4 of Schedule 13D.

#### **Item 5. Interest in Securities of the Issuer.**

**(a) and (b)** The Reporting Persons beneficially own Common Shares as follows:

Zipper directly beneficially owns the securities identified above in the form of direct ownership of 8,333,333 shares of Common Stock. Dyne is the sole member of Zipper and is deemed to beneficially own the securities (1) owned directly by Zipper. Dyne directly beneficially owns 1,150,667 shares of Common Stock, which includes (i) 835,667 shares held directly by Dyne and (ii) 315,000 shares issuable upon exercise of options held by Dyne that are currently exercisable.

(2) The calculation of the percentage is based on 90,757,517 shares of Common Stock outstanding on July 22, 2013.

(c) No Reporting Person has effected any transactions with respect to the Common Stock in the past 60 days, other than the transaction reported herein.

(d) No person (other than the Reporting Persons) is known to have the right to receive or the power to direct the receipt of dividends from, or the proceeds from the sale of, the Common Shares.

(e) Not applicable.
