Item 8.01 Other Events.

On August 6, 2013, Transocean Ltd. (the "Company") issued a press release announcing the schedule for the payment of the second of four quarterly dividend installments totaling \$2.24 per share, which was approved by the shareholders at the Company's 2013 Annual General Meeting held on May 17, 2013. The Company will pay the second installment of \$0.56 in accordance with the following schedule:

▲August 21, 2013 - Ex-dividend date

▲August 23, 2013 - Record date

♠September 18, 2013 - Installment payment date to U.S. and Swiss shareholders

For shareholders who choose to receive the second dividend installment in Swiss francs, the dividend payment will be converted into Swiss francs as transacted by Computershare on or about September 16, 2013. The period to elect to receive payment of the second dividend installment in Swiss francs starts on August 26, 2013, 5 p.m. Eastern Daylight Time (EDT), 11 p.m. Central European Summer Time (CEST), and ends on August 30, 2013, 5 p.m., EDT, 11 p.m. CEST.

The Company's press release is filed as Exhibit 99.1 to this Current Report on Form 8-K and is incorporated herein by reference. Statements regarding the proposed dividend and timing of dividend payment dates, as well as any other statements that are not historical facts, are forward-looking statements that involve certain risks, uncertainties and assumptions. Should one or more of these risks or uncertainties materialize, or should underlying assumptions prove incorrect, actual results may vary materially from those indicated.
