- Arun Mittal has beneficial ownership of 78,000 shares: 8,000 directly and 70,000 indirectly through 10,000 shares of Restricted Stock and an Option to acquire 60,000 shares held Caravan Partners LLC, a wholly-owned affiliate of Mr. Mittal. Mr. Mittal provides business development services to the Trust through Caravan Partners, LLC. The Option and Restricted Stock awards vest in three-equal annual installments beginning with the first anniversary of the respective grants. The Options have a 10-year term and a strike price equal to the closing price of date of the grant of August 13, 2012.
