Capital Group International, Inc. CGII does not have investment power or voting power over any of the securities reported herein. However, by virtue of Rule 13d-3 under the Act, CGII may be deemed to "beneficially own" 43,521,490 shares or 6.4% of the 680,437,525 shares of Ordinary Shares believed to be outstanding.
