- (1) Represents a portion of base salary paid to the Reporting Person in bi-weekly installments of fully vested shares. - (4) Between August 4, 2010 and October 26, 2010 the Reporting Person acquired 7 shares of First Midwest Bancorp, Inc. Common Stock under the First Midwest Bancorp, Inc. Non-Qualified Gain Deferral Plan pursuant to the Dividend Reinvestment feature of the Plan. This information is based on a plan statement dated October 12, 2010.

- (5) Between August 4, 2010 and October 26, 2010 the Reporting Person acquired 5 shares of First Midwest Bancorp, Inc. Common Stock under the First Midwest Bancorp, Inc. Savings and Profit Sharing Plan pursuant to the Dividend Reinvestment feature of the Plan. This information is based on a plan statement dated October 18, 2010.
