**EXPLANATORY STATEMENT**

Pursuant to Item 512(a)(3) of Regulation S-K, this Post-Effective Amendment No. 1 to Registration Statement on Form S-8 (File No. 333-110392) filed on November 12, 2003 is filed to deregister certain securities remaining available for issuance under such Registration Statement as described below.

On November 12, 2003, Automatic Data Processing, Inc. (the Registrant) filed a Registration Statement on Form S-8 (File No. 333-110392) to register an aggregate of 35,000,000 shares of common stock, par value \$0.10 per share (the Common Stock), under the Automatic Data Processing, Inc. 2000 Stock Option Plan (the 2000 Stock Option Plan). On November 11, 2008, at the Registrant's annual meeting of stockholders, the Registrant's stockholders approved the adoption of the 2008 Omnibus Award Plan (the 2008 Plan). In connection with the approval of the 2008 Plan no future awards will be made under the 2000 Stock Option Plan. Certain shares of Common Stock that remain available for issuance under the 2000 Stock Option Plan and that are not subject to outstanding awards under the 2000 Stock Option Plan are to be included in the shares of Common Stock available for issuance under the 2008 Plan (collectively, the Carried Forward Shares).

This Post-Effective Amendment No. 1 is being filed to deregister the Carried Forward Shares. The Registrant is filing a separate Registration Statement on Form S-8 (the 2008 Plan Registration Statement) to register the Carried Forward Shares for issuance under the 2008 Plan and to carry over the filing fees for the Carried Forward Shares.

In accordance with the principles set forth in Interpretation No. 89 under Section G of the Manual of Publicly Available Telephone Interpretations of the Division of Corporation Finance of the Securities and Exchange Commission (July 1997) and Instruction E to the General Instructions to Form S-8, the Registrant is filing this Post-Effective Amendment No. 1 (i) to reallocate the Carried Forward Shares from the 2000 Stock Option Plan to the 2008 Plan and (ii) to carry over the registration fees paid with respect to the Carried Forward Shares from the Registration Statement on Form S-8 (File No. 333-110392), filed for the 2000 Stock Option Plan, to the 2008 Plan Registration Statement.
