#### Item 1.01 Entry into a Material Definitive Agreement

Pursuant to an agreement, dated as of March 26, 2012, the credit facility we obtained in connection with our purchase of Oasis of the Seas was assigned from Oasis of the Seas Inc., our subsidiary which owns the ship, to Royal Caribbean Cruises Ltd. A similar assignment was simultaneously made from the ship-owning subsidiary to Royal Caribbean Cruises Ltd. for the facility relating to Allure of the Seas.

Other than the change in borrower, the economic terms of these facilities remain unchanged. These amended facilities each contain covenants substantially similar to the covenants, in our other parent-level ship financing agreements and our revolving credit facilities.
