- (1) This Form 4 is being filed by Bank of America Corporation ("BAC"), a Delaware corporation and bank holding company registered under the Bank Holding Company Act of 1956, on behalf of its subsidiaries. BAC consummated a merger with Merrill Lynch Co., Inc. ("ML&Co.") on January 1, 2009, after which ML&Co. became a direct wholly owned subsidiary of BAC.
- (2) Transaction executed by the error correction section of Merrill Lynch, Pierce, Fenner & Smith Incorporated ("MLPFS"), a broker-dealer and subsidiary of BAC, to correct errors made in connection with trades made on behalf of clients of MLPFS.
- (3) Each of BAC, ML&Co., MLPFS, and Merrill Lynch Group, Inc. ("ML Group", and collectively the "Reporting Persons") disclaims beneficial ownership of these securities, except to the extent of its pecuniary interest therein. In connection with all of the transactions reported on this Form, the Reporting Persons have agreed to voluntarily remit appropriate profits, if any, to BlackRock, Inc. The Reporting Persons disclaim that the transactions reported on this Form 4 are subject to reporting under Section 16(a) or disgorgement under Section 16(b), and this report shall not be deemed an admission that those sections apply to these transactions.
- (4) BAC owns the Common Stock indirectly through its wholly owned subsidiaries ML Group and MLPFS.
- (5) Excludes up to 774 shares of Common Stock previously held and reported as held in discretionary client accounts, which ML&Co. may have been deemed not to beneficially own pursuant to Rule 16a-1(a)(5)(ii) and in which ML&Co. did not have a pecuniary interest.
- (6) Pursuant to the Second Amended and Restated Stockholder Agreement dated as of February 27, 2009, as may be amended from time to time, between ML&Co., ML Group and the Issuer, ML&Co. has the right to designate two members to the board of directors of the

Issuer. Each of the Reporting Persons other than ML&Co. disclaims its possible status as director of the Issuer.
