The following constitutes Amendment No. 7 to the Schedule 13D filed by the undersigned (“Amendment No. 7”). This Amendment No. 7 amends the Schedule 13D as specifically set forth herein.

Item 3. Source and Amount of Funds or Other Consideration.

Item 3 is hereby amended and restated to read as follows:

The Shares purchased by H Partners LP and the Offshore Fund and the Shares held in the H Partners Account were purchased with working capital (which may, at any given time, include margin loans made by brokerage firms in the ordinary course of business) in open market purchases. The aggregate purchase price of the 4,663,100 Shares beneficially owned by H Partners LP is approximately \$189,099,498, excluding brokerage commissions. The aggregate purchase price of the 1,758,100 Shares beneficially owned by the Offshore Fund is approximately \$80,075,702, excluding brokerage commissions. The aggregate purchase price of the 1,188,800 Shares held in the H Partners Account is approximately \$51,602,854, excluding brokerage commissions.

Item 5. Interest in Securities of the Issuer.

Items 5(a) – (c) are hereby amended and restated to read as follows:

The aggregate percentage of Shares reported owned by each person named herein is based upon 53,897,463 Shares outstanding as of May 4, 2017, which is the total number of Shares outstanding as reported in the Issuer’s Quarterly Report on Form 10-Q filed with the Securities and Exchange Commission on May 10, 2017.

A. H Partners Management

As of the close of business on May 10, 2017, H Partners Management, as the investment manager, may be deemed (a) the beneficial owner of 7,610,000 Shares, which consists of the Shares held in the H Partners Account and the Shares owned by the Funds.
