Recently, those of you who own shares of Ryder stock received a proxy statement and voting card for our 2008 Annual Meeting of Shareholders, which will be held on Friday, May 2, 2008 at Ryder's headquarters in Miami. Accompanying these materials is a copy of Ryder's 2007 Annual Report, in which we highlight Ryder's 75th anniversary and our history of delivering reliability, efficiency and productivity to our customers.

There are three agenda items for this year's annual meeting: the election of three directors; the approval of an amendment to Ryder's Equity Compensation Plan; and the ratification of PricewaterhouseCoopers LLP as Ryder's independent auditor.
