- (1) On January 5, 2006, the National Information Consortium Voting Trust ("Voting Trust"), for which Messrs. Jeffery S. Fraser and Ross C. Hartley act as trustees, sold 2,000,000 shares of NIC Inc. ("NIC") common stock. The Reporting Person has neither voting nor investment control over the NIC shares held by the Voting Trust, and did not participate in the decision to sell the shares. As a result of the sale, the Reporting Person now indirectly owns 102,881 shares of NIC common stock, which are held directly by the Voting Trust for the benefit of the Reporting Person as a direct beneficiary of the Voting Trust.
- (2) The Reporting Person also directly owns 24,301 shares of NIC common stock and stock options to purchase 55,000 shares of NIC common stock at \$4.15 per share, exercisable in four equal installments, beginning on November 5, 2005.
