AWM also serves as the general partner of MGP Advisers Limited Partnership (MGP), the general partner of and investment adviser to Special Situations Fund III, L.P. (SSF3) and Special Situations Fund III QP, L.P.* (SSFQP). Marx and Greenhouse are also members of MG Advisers L.L.C. (MG), the general partner of and investment adviser to Special Situations Private Equity Fund, L.P. (SSPE). (SSF3, SSFQP, Cayman, and SSPE will hereafter be referred to as, the Funds). The principal business of each Fund is to invest in equity and
