(1) Under the ULT Supplemental Stock Purchase Plan, Mr. Moore held 62.994 phantom stock units. He acquired 17.708 phantom stock units on a periodic basis during the previous quarter. The ULT Supplemental Stock Purchase Plan was frozen effective January 1, 2007, with no further accruals of phantom stock after that date. The Plan administrator used the December 29, 2006 closing price to convert the 62.994 phantom stock units into an equivalent cash amount which will be distributed at the later date.
