- (1) Shares of common stock acquired upon the vesting of performance stock units awarded on February 20, 2009.  - (7) These restricted stock units vest in two equal installments on the third and fourth anniversaries of their dates of grant, March 7, 2008, February 20, 2009, February 8, 2010, and February 7, 2011.
