- (1) Restricted Stock Units (RSUs) granted under the PG&E Corporation 2006 Long-Term Incentive Plan (LTIP). RSUs are payable in shares of PG&E Corporation common stock on a one-for-one basis upon the earliest of one year from the date of grant, a director's death, disability, retirement, or a change in control, as defined in the LTIP.
- (2) This total includes 1,244.94 units of phantom stock granted under the PG&E Corporation Non-Employee Director Stock Incentive Plan (SIP), and reflects the acquisition of 12.13 units of phantom stock on 7/16/12, 12.88 units of phantom stock on 10/15/12, 13.53 units of phantom stock on 1/15/13, and 11.99 units of phantom stock on 4/15/13, pursuant to a dividend reinvestment feature of the SIP. This total also reflects the acquisition of 80.9 RSUs on 7/16/12, 85.90 RSUs on 10/15/12, 90.26 RSUs on 1/15/13, and 80.01 RSUs on 4/15/13 pursuant to a dividend reinvestment feature of the LTIP. The phantom stock units and the RSUs are automatically payable in shares of PG&E Corporation common stock only.
