(1) Restricted Stock Units granted under the PG&E Corporation 2014 Long-Term Incentive Plan (LTIP). RSUs are payable in shares of PG&E Corporation common stock on a one-for-one basis upon the earliest of one year from the date of grant, a director's death, disability, or certain change-in-control-related events as described in the LTIP.

(2) This total includes 1,754.70 units of phantom stock granted under the PG&E Corporation Non-Employee Director Stock Incentive Plan (SIP), and reflects the acquisition of 16.57 phantom stock units on 7/15/13, 19.27 phantom stock units on 10/15/13, 19.30 phantom stock units on 1/15/14, and 17.46 phantom stock units on 4/15/14 pursuant to a dividend reinvestment feature of the SIP. The total also reflects the acquisition of 73.59 RSUs on 7/15/13, 85.56 RSUs on 10/15/13, 85.70 RSUs on 1/15/14, and 77.55 RSUs on 4/15/14 pursuant to a dividend reinvestment feature of the LTIP. The phantom stock units and RSUs are automatically payable in shares of PG&E Corporation common stock only. This total also includes 6,120.02 shares held in the PG&E Corporation Dividend Reinvestment and Stock Purchase Plan (DRSPP), and reflects 153.33 shares acquired on 7/15/13, 175.04 shares acquired on 10/15/13, 176.27 shares acquired on 1/15/14, and 161.51 shares acquired on 4/15/14 pursuant to a dividend reinvestment feature of the DRSPP.
