Patient Safety Technologies, Inc. (the "Company") anticipates that its revenue for the six months ended June 30, 2008 will significantly exceed its revenue for the six months ended June 30, 2007. The increase in revenue is the result of an increase in sales of the Company's Safety-Sponge^M System during the 2008 period. The Company anticipates that its operating expenses will be significantly greater than the six months ended June 30, 2008 as a result of increases in salary and marketing expenses. The net loss for the six months ended June 30, 2008 is expected to be slightly more than the six months ended June 30, 2007 primarily as a result of these factors.

A reasonable estimate of the results cannot be made at this time due to the fact that the compilation, dissemination and review of the information required to be presented in the Form 10-Q has not been completed.
