DEREGISTRATION OF UNSOLD SECURITIES

On September 5, 2006, Synvista Therapeutics, Inc., formerly known as Alteon Inc. (the "Company"), filed a registration statement on Form S-8 (File No. 333-137115) (the "Registration Statement").
