ITEM 2.02. RESULTS OF OPERATIONS AND FINANCIAL CONDITION

On September 12, 2006, the Company announced financial results for the fiscal year and quarter ended June 30, 2006.

Contango Oil & Gas Company (AMEX:MCF) reported a net loss attributable to common stock for the year ended June 30, 2006 of \$0.8 million, or \$0.05 per

basic and diluted share, compared to net income attributable to common stock for the year ended June 30, 2005 of \$12 million, or \$0.92 per basic and diluted share. EBITDAX for the year ended June 30, 2006 was \$10.0 million compared to \$28.5 million for the year ended June 30, 2005.

For the three months ended June 30, 2006, Contango had a net loss attributable to common stock of \$1.2 million, or \$0.08 per basic and diluted share, compared to a net loss attributable to common stock for the three months ended June 30, 2005 of \$1.4 million, or \$0.10 per basic and diluted share. Natural gas and oil sales from continuing and discontinued operations for the three months ended June 30, 2006 were \$1.1 million, down from \$1.3 million for the three months ended June 30, 2005.
