These shares were acquired pursuant to a restricted stock unit award granted on June 11, 2010 under the Veeco Instruments Inc. 2010 Stock Incentive Plan. This criteria was met and, as a result, the restrictions on one-third of these awards lapsed on August 2, 2011 (the "Initial Vesting Date"). The restrictions on an additional one-third of these shares shall lapse on each of the first and second anniversaries of the Initial Vesting Date.
