(1) The transactions reported in this Form 4 were effected pursuant to a Rule 10b5-1 trading plan adopted by the reporting person on July 29, 2005. Pursuant to the plan, 16,000 stock options will be exercised on the first day of each month for a six month period; of the 16,000 shares purchased by the exercise of these options, 11,000 shares will be immediately sold and 5,000 shares will be held.
