- 100% of this option grant is exercisable as of 11/16/05, the vesting start date. Shares underlying the options are restricted from transfer,
- (1) with the restriction lapsing with respect to 25% of the shares on each subsequent anniversary of the vesting start date, so that all underlying shares will be free from transfer restrictions on 11/16/09.
 - (2) Converts to common stock on a one-for-one basis.
 - (3) Stock units will be paid in an equal number of shares of the Issuer's common stock upon vesting of the units. 25% of the units will cliff vest on each annual anniversary of 10/23/06, the vest start date, so that all of the units will have vested on 10/23/10.
 - (4) Not applicable.
 - (5) 25% of the option grant is exercisable on 1/12/2008, and 1/48 of the option grant is exercisable each month thereafter.
 - (6) 25% of the option grant is exercisable on 1/11/2009, and 1/48 of the option grant is exercisable each month thereafter.
